Course Description

Inspiring and Leading through Excellence in Education is the shared vision of the USD School of Education for all of its programs. The underlying intent of the vision requires that students be exposed to learning experiences that will enhance their ability to engage in life-long learning and leadership roles anchored in reflective practice. This first year seminar for high school juniors and seniors is designed to help students prepare for the college experience both academically and personally. The seminar will encourage students to explore the field of education, identify practices and experiences to help them be successful in their college and professional careers, and to demonstrate proficiency in discussion, reflection, writing, and the use of technology.
